## LIABILITY WAIVER

I hereby acknowledge and agree that participation in target practice within Rocky Mountain Archery has inherent risks. In consideration of the services provided Rocky Mountain Archery, their employees and all persons or entities acting in any capacity on their behalf I now agree and certify as follows:

- 1. Archery is a sport that involves the use of high energy equipment. I acknowledge and fully understand the inherent risks of the activities that may involve risk of serious injury which might result, not only from my own actions, inactions, or negligence, but from the actions, inactions, or negligence of others or the conditions of the premises or of any equipment used. I acknowledge that the following describes some, but not all of the risks of participation in this sport.
  - a. Bruising or abrasion of the arms from improperly firing the bow.
  - b. Fatigue, chill and/or dizziness, which may increase the risk of accident;
  - c. The presence and actions of other participants.;
  - d. Misuse of equipment or facilities, or failure of equipment;
- 2. Further, that there may be other risks not known or not reasonably foreseeable at this time. The risks may include, but are not limited to: the nature of the activity, latent or apparent defects of conditions in equipment or property supplied by Rocky Mountain Archery; acts of other participants in this activity, employees or agents of Rocky Mountain Archery; my own physical condition, acts of omissions; viruses and illnesses including, but not limited to COVID-19, conditions of Rocky Mountain Archery's facility and surrounding grounds or terrain and accidents connected with their use; first aid emergency treatment or other services.
- 3. I expressly agree and promise to accept and assume all the risks existing in this activity. My participating in this activity is purely voluntary and I elect, in spite of the risks, to participate. I assume all the foregoing risks and accept personal responsibility for the damages following such injury.
- 4. On behalf of myself, my children, my parents, assigns, personal representatives, I hereby voluntarily release, waive, forever discharge, and agree to indemnify and hold harmless Rocky Mountain Archery and each of their agents, and other employees and if applicable, operators or lessors of premises used to conduct the event/activity, from any and all liability for any and all claims, demands of causes of action which are in any way connected with my participation in this activity or my use of Rocky Mountain Archery's equipment or facilities.
- 5. I hereby certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating in these activities or alternatively I agree to bear the cost of such injury or damage myself.
- 6. I will be provided with an optional arm guard if renting, which is recommended to be worn at all times when using a bow.
- 7. I hereby certify that I (or the participant under 18) will not be under the influence of alcohol, tobacco, illegal drugs, or prescription drugs that have not been prescribed by a medical doctor to treat a current medical condition, during the event or at any time that may affect my ability to participate in the event.
- 8. I hereby give Rocky Mountain Archery permission to administer basic first aid, and I authorize Rocky Mountain Archery (or its agents or employees) to contact 911 or other emergency personnel as needed.

I hereby certify that I am at least 18 years old, or the parent or legal guardian of the participant under 18. By signing this document, I acknowledge that if anyone is hurt, or property is damaged during participation in this activity, a court of law may find me to have waived my right to maintain a lawsuit against Rocky Mountain Archery and each of the parties listed in Paragraph 4 above on the basis of any claim from which I have released them herein.
